- 1. Approval of op-ed on H.Res. 907
 - Danielle asked what strategy would we like to pursue? It could be a lengthy or short depending on who we are targeting.
 - We need to expediate the process while this is still relevant
 - Sam believes Vira submitted a short version that is succinct and to the point
 - Meena brought up a need for an assigned media person in the future
 - Danielle brought up that letters to the editor must respond to an existing article, which limits which outlets we can send it to
 - Meena recommends to defer to the Chair and Vice Chair to consolidate the different statements and voices.
 - Bora motions to approve the version submitted by Vira on Moulton's statement, Mabel seconds.

 - Motion passed unanimously
 - Vira brought up interest in having a joint letter with Leverett Wing
- 2. Approval of AAC support on APIsCAN Public Statement on COVID-19
 - Betty expressed concerns that it comes across as partisan. It is a very broad statement that hits many different points. Betty shared the statement is happening to all communities, not just Asian Americans.
 - Bora expresses that signing on would indicate that we are backing their statement as a Commission.
 - Meena motions to approve AAC signing onto the APIsCAN public statement, Mabel seconds

 - o No: Betty
